I an directed to invite a reference to Punjab Government circular letter No. 3/1/98-5FPII/1473 I dated 18.11.1998 and to say that after careful consideration of the recommendations of the Fifth Punjab Pay Commission, the Governor of Punjab is pleased to decide as under:-

- (a) The existing Special Allowance attached to certain posts in terms of para (ii) and (iii) of the letter under reference, except in the case of Chowkidars for which separate orders have been issued vide Government letter No.3/10/2010-5FP 2/475 dated 13/10/2010, shall stand doubled with effect from the 1st October, 2010.
- (b) The existing Special Allowance attached to certain posts of the departments mentioned in ANNEXURE A to this letter, shall be revised with effect from the 1st October, 2010, as indicated against each post.
- Before drawal of the revised Special Allowance in terms of para 1(a) of this circular letter, each Head of the Department/ Head of the Office will ensure from the original records that the revised Special Allowance is claimed in respect of those posts/employees only for which Special Allowance has been authorised by the Department of Finance. In case of any doubt, the matter will be settled in consultation with the Department of Finance. Each Head of the Department will also supply information to the Department of Finance (Finance Personnel II Branch) in the performa enclosed as ANNEXURE-B to this letter to enable this department to prepare an authentic list of the categories of posts/employees to which this allowance is admissible.
- 3. The other existing terms and conditions for grant of Special Allowance shall continue to be in force.
- The Punjab version of these orders will follow in due course.
